Terms and conditions

1. The Competition is organised by Chery International Proprietary Limited trading as iCAUR South Africa, Registration Number: 2021/355670/07 and Absa Bank Limited trading through its Vehicle and Asset Finance Division (Registration No 1986/004794/06) (“**Organisers**”). The following terms and conditions apply solely to the “Buy and finance an iCAUR through iCAUR FINANCE – a product of Absa and stand a chance to have up to R200,000 of your vehicle finance settled by iCAUR FINANCE – a product of Absa” promotional competition (“**Competition**”) offered by the Organisers.
2. The Competition starts on **15 June 2026** and ends on **31 October** (both dates inclusive) (“**Competition Period**”). These dates change at the sole discretion of the Organisers and **entries received before or after the Competition Period will not qualify, are invalid and will, therefore, not be considered.**
3. The Organisers may revise, change, adjust or vary these terms and conditions. If/when the Organisers revise, change, adjust or vary these terms and conditions:
 - 3.1. they will do so at their sole discretion;
 - 3.2. they will notify the participants in competition (“**Participants**”) in the same place/s where these terms and conditions are published. Such amendments shall be deemed to have taken effect from the date of publication of the revised terms and conditions on the Organisers’ website; and
 - 3.3. no Participant will have a claim against the Organisers or the Organiser’s representatives because of that.
4. By participating the Competition, Participants are deemed to have read, understood and consented to these terms and conditions and agree to be bound by each term. Information regarding the Competition that is published on authorised advertising material will also form part of these terms and conditions of the Competition.
5. Organisers’ decision regarding any matter relating to the Competition will be final and binding on Participants and no further correspondence will be entered into.
6. **Who may qualify as a participant?**
To qualify as a Participant and a winner, you must:
 - 6.1. be a natural person (not a juristic entity);
 - 6.2. be 18 years or older;
 - 6.3. have purchased a new iCAUR vehicle;
 - 6.4. have financed your new iCAUR vehicle through iCAUR FINANCE – a product of Absa;
 - 6.5. have kept your motor vehicle finance account with iCAUR FINANCE – a product of Absa up to date (no arrears) account from the date of signing the credit agreement to the Competition Draw Date (a monthly date from 15 June 2026 to 31 October 2026);
 - 6.6. not be:
 - 5.1.1. directors, members, partners, employees, agents of or consultants of the Organisers;
 - 5.1.2. directors, members, partners, employees, agents of or consultants of the Organisers’ subsidiaries, holding companies, divisions and/or associated companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by the Organisers;
 - 5.1.3. not be employees of Absa or iCAUR; or
 - 5.1.4. spouses, life partners, immediate family members or business partners of directors, members, partners, employees, agents of or consultants of the Organisers’ employees.
7. **How to enter/participate in the competition?**
A person who meets the requirements of **Error! Reference source not found.** above, will be automatically added to the draw (and will have entered the Competition) when they purchase and finance new iCAUR vehicle through iCAUR FINANCE – a product of Absa.
8. **Draw**
 - 8.1. The Organisers will conduct monthly random draws to select one winner per month during the Competition Period. A total of five winners will be selected during the Competition Period.
 - 8.2. The first draw will relate to Competition entries received from 15 June 2026 to 30 June 2026 and will be conducted in July 2026.
9. **Prize**
 - 9.1. Each winner will receive not more than R200,000 of a settlement amount towards their iCAUR FINANCE – a product of Absa finance account (“**Prize**”).
10. **Publicity and data privacy**
 - 10.1. By participating in the Competition, each Participant acknowledges that personal information about the Participant will be shared with the Organisers and their agents to the extent necessary to conduct the Competition and for the prize to be delivered to prize winner.

- 10.2. The Organisers may request that images/likeness of the winner be taken for publicity and advertising purposes, without the winner being entitled to any payment in consideration for such images. **The winner does not have to agree to have their image/likeness taken for this purpose.**
- 10.3. All personal information relating to the Participants will be used solely for the purpose of this Competition and in accordance with the relevant data protection legislation. The Participant may deny and/or (after having given it) withdraw their consent in relation to this Competition at any time.
- 10.4. Participants understand and agree that they will have no entitlement to royalties of the Organisers whatsoever, payment for pictures, videos, live feeds, recordings and the like captured of their participation of the Competition or profits made by Organisers for sales, public exposure or otherwise emanating from the content of or involving Participants that are used as aforesaid and the Participants hereby waive all claims for same and indemnify the Organisers from such claim now and in future.

11. General

The Organisers reserve the right to shorten, extend, suspend the period of the Competition or terminate the Competition without having chosen a winner whenever it should so choose for technical, commercial, or operational reasons, or for reasons beyond its control or generally for any reason whatsoever within their sole discretion. In such an event, all Participants waive any rights that they may have/purport to have in terms of this Competition and acknowledge that they will have no right or recourse against the Organisers whatsoever in this regard.

The Participant waives any right which she/he may have against the Organisers as a result of such cancellation, suspension or termination of the Competition and completely indemnifies the Organisers from any claim arising therefrom.

To the fullest extent permitted by law, by participating in this Competition, the Participant indemnifies, releases and agrees to hold harmless the Organisers, their associated, holding and subsidiary companies, and their directors, officers, agents, representatives, shareholders, employees, successors and assigns from any and all claims or liability arising from participating in the Competition.

To the extent permitted by law, the Organisers will not be liable in any way whatsoever, for any claims arising from inaccurate information supplied by Participants. By participating in this Competition, Participants commit to always providing the Organisers with correct information.

RSA law shall govern these Competition terms and conditions, and the Courts of the RSA shall have jurisdiction.
